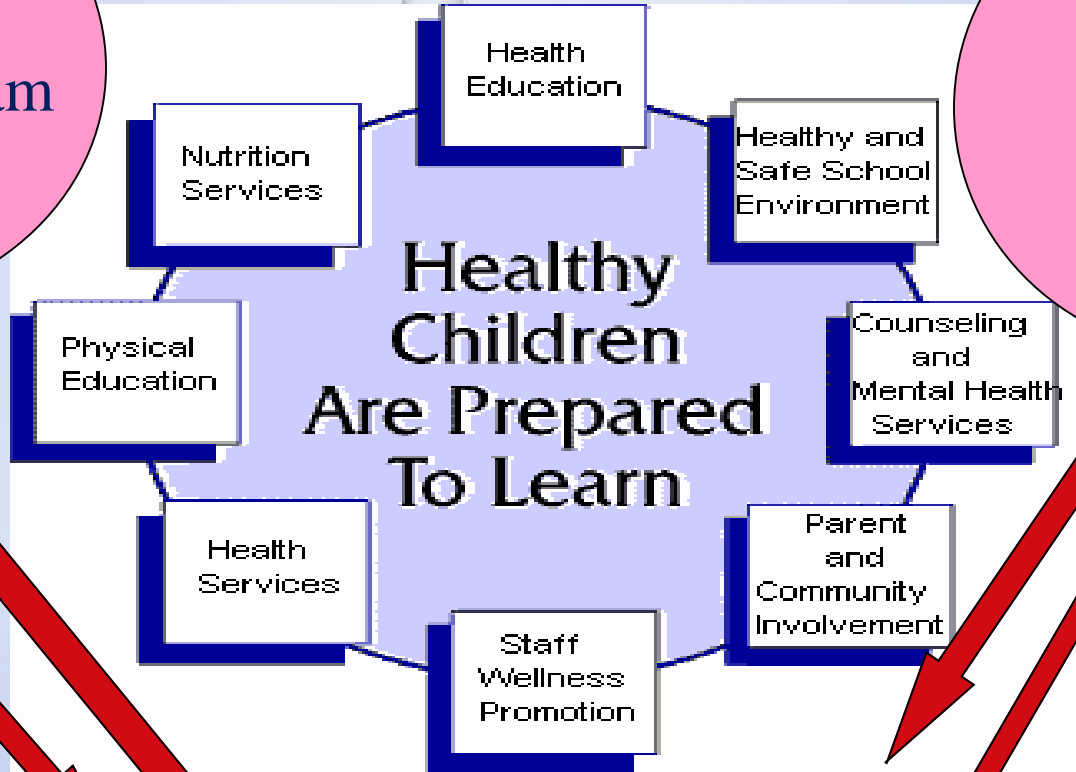

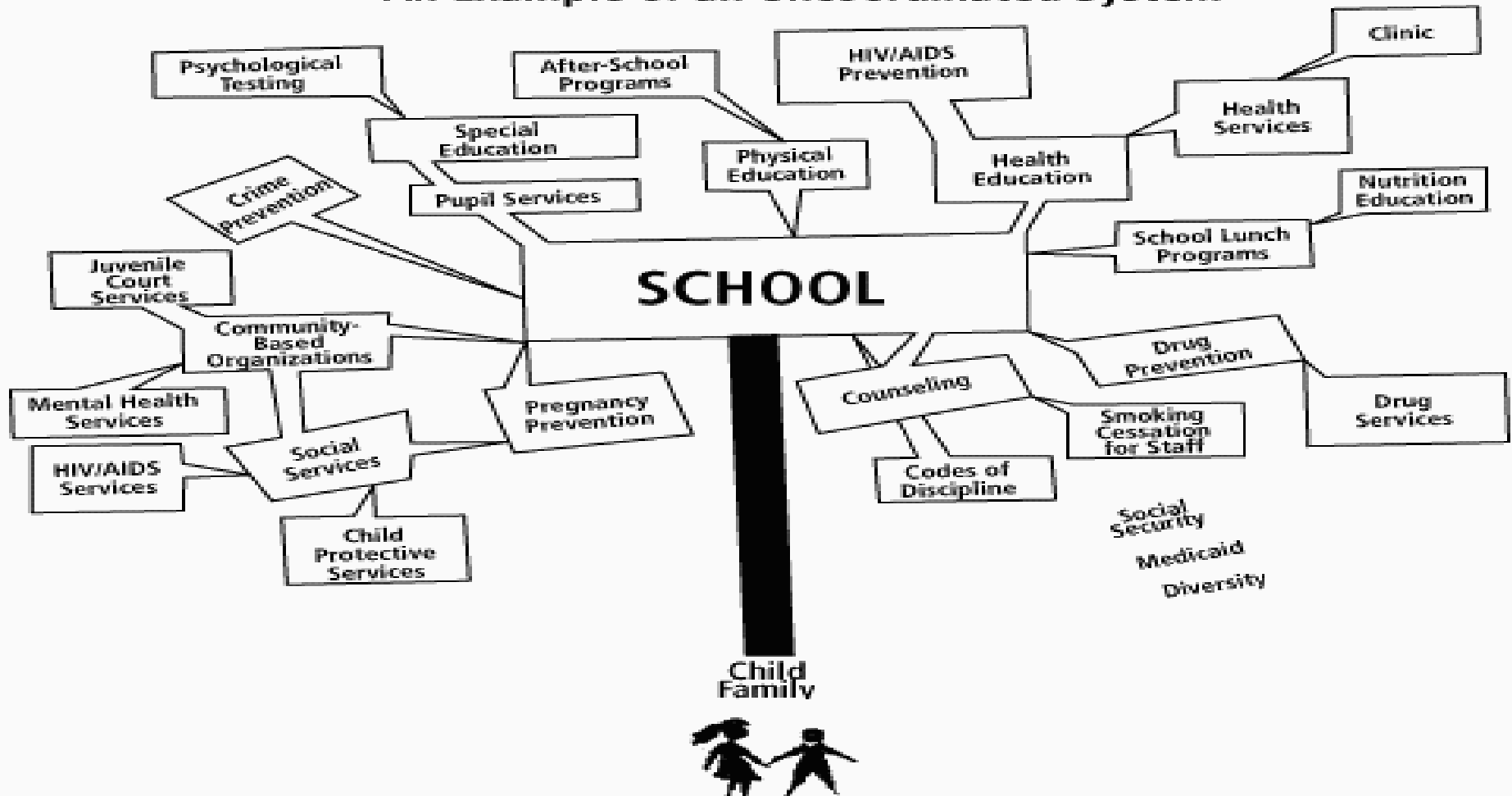

YOUTH RISK BEHAVIORS

- Tobacco Use
- Poor Food Choices and Inappropriate Portion Sizes
- Inadequate Physical Activity
- Alcohol and Drug Use – Opioid Epidemic
- Sexual Behaviors that can Transmit HIV and Other STD's
- Unintended Pregnancy
- Intentional and Unintentional Injuries, often due to domestic violence

COUNSELING AND PSYCHOLOGICAL SERVICES

- Services provided to improve students mental, emotional and social health.
- May include individual and group activities that assess, intervene and refer to appropriate services.

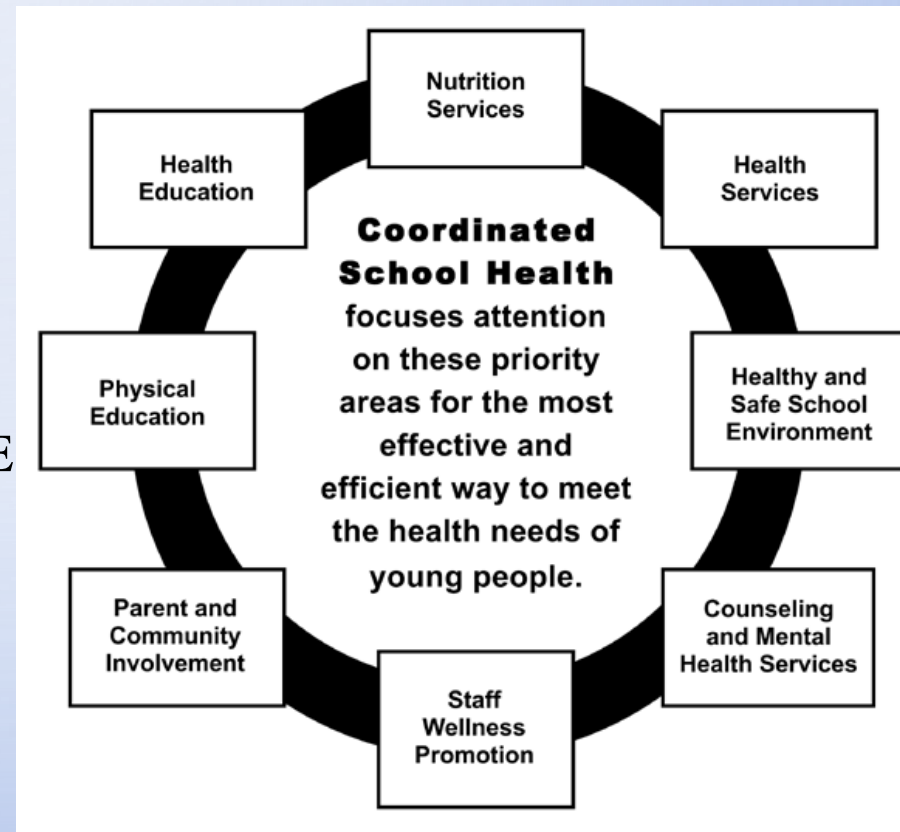

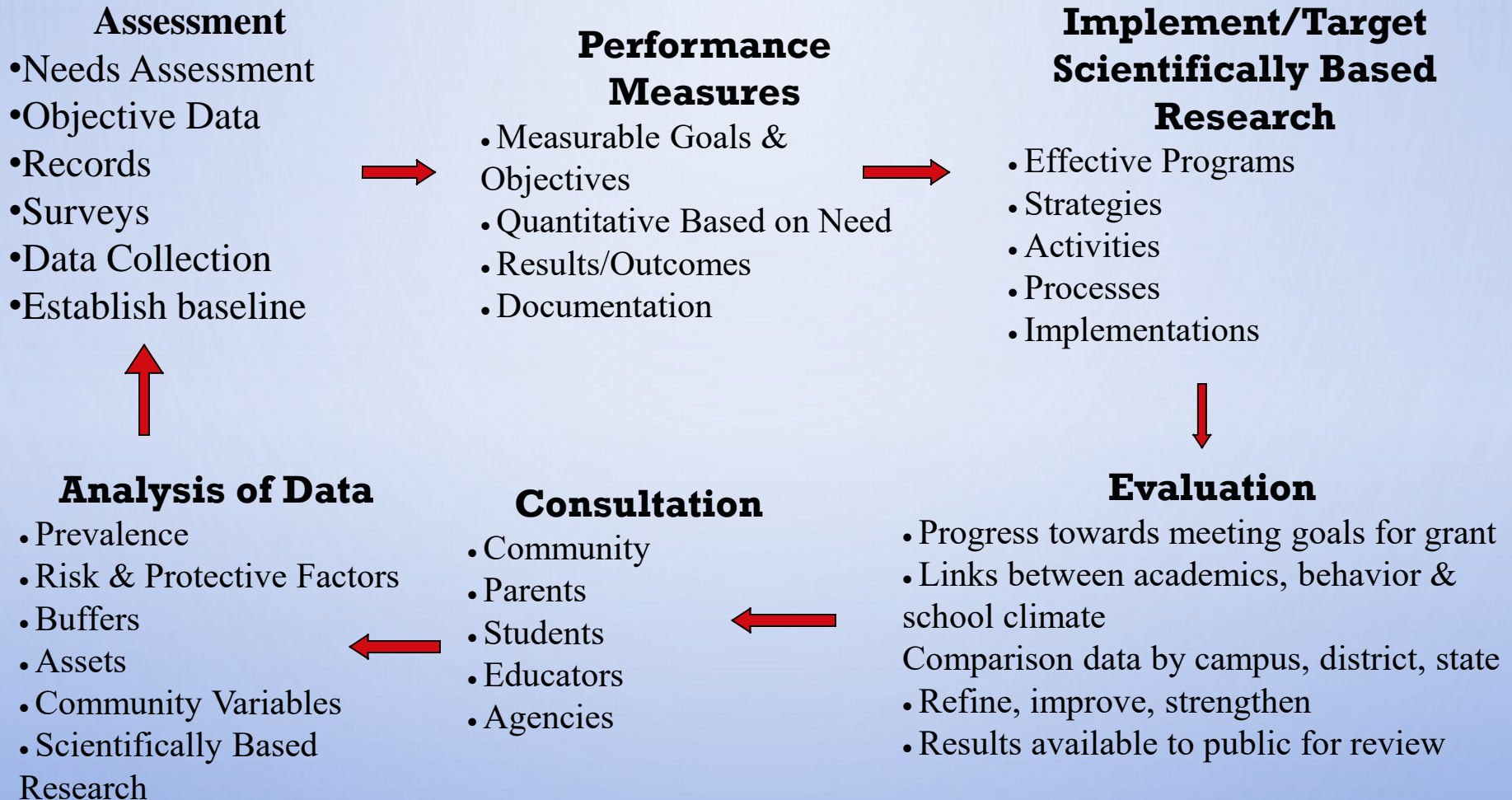

WHY COORDINATED SCHOOL HEALTH?

Six Categories Of Risk Behaviors:

- ✓ Intentional & Unintentional Injuries, Often Due To Violence
- ✓ Alcohol & Drug Use Tobacco Use
- ✓ Sexual Behaviors - HIV And Other Std's
- ✓ Unintended Pregnancy
- ✓ Poor Food Choices And Inappropriate Portion Sizes
- ✓ Inadequate Physical Activity

***SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC
§28.004***

Board Of Trustees Shall...

- (A) Establish A Local SHAC
- (B) District Must Consider Recommendations Of The SHAC Before Changing The District's Health Education Curriculum Or Instruction
- (C) The Board Of Trustees Shall Determine The Specific Content Of The District's Instruction In Human Sexuality, In Accordance With Subsections (E), (F), And (G).

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

- (D) Appoint at Least 5 Members To The Local SHAC
- Majority Of The Members Must Be Parents Of Students Enrolled In The District And Who Are NOT Employed By The District.
 - One Of Those Members Shall Serve As Chair Or Co-chair Of The Council.

(D-1) Must Meet 4 Times Per Year

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

May Appoint Persons From Following Groups Or A Representative From A Group
Other Than A Group Specified

- (1) Public School Teachers;
- (2) Public School Administrators;
- (3) District Students;
- (4) Health Care Professionals;
- (5) The Business Community;
- (6) Law Enforcement;
- (7) Senior Citizens;
- (8) The Clergy;
- (9) Nonprofit Health Organizations; And
- (10) Local Domestic Violence Programs.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

SHAC Duties include Recommending:

- (1) Number of **hours** of instruction to be provided in **health education**
- (2) Curriculum appropriate for specific grade levels designed to prevent obesity, cardiovascular disease, and **Type 2 diabetes** through coordination of:
 - (A) health education;
 - (B) physical education and physical activity;
 - (C) nutrition services;
 - (D) parental involvement; and
 - (E) instruction to prevent the use of tobacco;
- (3) appropriate **grade levels** and **methods of instruction** for **human sexuality** instruction; and

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

SHAC Duties Include Recommending:

- (4) Strategies For Integrating The Curriculum Components Specified By Subdivision (2) With The Following Elements In A **Coordinated School Health** Program For The District:
 - (A) School Health Services;
 - (B) Counseling And Guidance Services;
 - (C) A Safe And Healthy School Environment; And
 - (D) School Employee Wellness.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

(E) Any Course Materials And Instruction Relating To Human Sexuality, Sexually Transmitted Diseases, Or Human Immunodeficiency Virus Must:

- (1) Present Abstinence From Sexual Activity As The Preferred Choice Of Behavior In Relationship To All Sexual Activity For Unmarried Persons Of School Age;
- (2) Devote More Attention To Abstinence From Sexual Activity Than To Any Other Behavior;
- (3) Emphasize That Abstinence From Sexual Activity, If Used Consistently And Correctly, Is The Only Method That Is 100 Percent Effective In Preventing Pregnancy, Sexually Transmitted Diseases, Infection With Human Immunodeficiency Virus Or Acquired Immune Deficiency Syndrome, And The Emotional Trauma Associated With Adolescent Sexual Activity;

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

(E) Any Course Materials And Instruction Relating To Human Sexuality, Sexually Transmitted Diseases, Or Human Immunodeficiency Virus Must:

- (4) Direct Adolescents To A Standard Of Behavior In Which Abstinence From Sexual Activity Before Marriage Is The Most Effective Way To Prevent Pregnancy, Sexually Transmitted Diseases, And Infection With Human Immunodeficiency Virus or Acquired Immune Deficiency Syndrome; and
- (5) Teach Contraception And Condom Use In Terms Of Human Use Reality Rates Instead Of Theoretical Laboratory Rates, If Instruction On Contraception And Condoms Is Included In Curriculum Content.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

- (F) A School District **May Not Distribute Condoms** In Connection With Instruction Relating To Human Sexuality.
- (G) A School District That Provides Human Sexuality Instruction **May Separate Students** According To Sex For Instructional Purposes.
- (H) Before Each School Year, A School District Shall Provide **Written Notice To A Parent** Of Each Student Enrolled In The District Of The Board Of Trustees' Decision Regarding Whether The District Will Provide **Human Sexuality Instruction** To District Students.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

If Instruction Will Be Provided, The Notice Must Include:

- (1) A **Summary** Of The Basic Content Of The District's **Human Sexuality** Instruction To Be Provided To The Student, Including A Statement Informing The Parent Of The Instructional Requirements Under State Law;

(2) A STATEMENT OF THE PARENT'S RIGHT TO:

(A) **REVIEW CURRICULUM MATERIALS AS PROVIDED BY SUBSECTION (J); AND**

(B) **REMOVE THE STUDENT FROM ANY PART OF THE DISTRICT'S HUMAN SEXUALITY INSTRUCTION WITHOUT SUBJECTING THE STUDENT TO ANY DISCIPLINARY ACTION, ACADEMIC PENALTY, OR OTHER SANCTION IMPOSED BY THE DISTRICT OR THE STUDENT'S SCHOOL; AND**

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

- (3) Information Describing The **Opportunities For Parental Involvement** In The Development Of The Curriculum To Be Used In Human Sexuality Instruction, Including Information Regarding The Local SHAC.
- (I-1) A Parent May Use The **Grievance Procedure** Adopted Under Section 26.011 Concerning A Complaint Of A Violation Of Subsection (I).
- (J) A School District Shall Make **All Curriculum Materials** Used In The District's Human Sexuality Instruction Available For **Reasonable Public Inspection**.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

(K) District Shall Publish In The Student Handbook & Post On The District's Internet Website

- (1) Statement Of The Policies Adopted To Ensure That Elementary School, Middle School, And Junior High School Students Engage In At Least The Amount And Level Of Physical Activity Required By Section 28.002(1);**
- (2) A Statement Of (A) The Number Of Times During The Preceding Year The District's SHAC Has Met;**

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

- (B) Whether The District Has Adopted And Enforces Policies To Ensure That District Campuses Comply With Agency **Vending Machine And Food** Service Guidelines For Restricting Student Access To Vending Machines; And
- (C) Whether The District Has Adopted And Enforces Policies And Procedures That Prescribe **Penalties** For The Use Of **Tobacco** Products By Students And Others On School Campuses Or At School-sponsored Or School-related Activities; And

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

(3) A Statement Providing Notice To Parents That They Can Request In Writing Their **Child's Physical Fitness** Assessment Results At The End Of The School Year.

(L) The Local School Health Advisory Council Shall Consider And Make Policy Recommendations To The District Concerning The Importance Of **Daily Recess For Elementary** School Students. The Council Must Consider Research Regarding Unstructured And Undirected Play, Academic And Social Development, And The Health Benefits Of Daily Recess In Making The Recommendations. The Council Shall Ensure That Local Community Values Are Reflected In Any Policy Recommendation Made To The District Under This Subsection.

SCHOOL HEALTH ADVISORY COUNCIL (SHAC) -TEC §28.004

(M) In Addition To Performing Other Duties, The Local School Health Advisory Council Shall **Submit To The Board** Of Trustees, At Least Annually, A **Written Report** That Includes:

- (1) Any Council Recommendation Concerning The School **District's Health Education Curriculum** And Instruction Or Related Matters That The Council Has Not Previously Submitted To The Board;
- (2) Any **Suggested Modification** To A Council Recommendation Previously Submitted To The Board; And
- (3) A Detailed Explanation Of The **Council's Activities** During The Period Between The Date Of The Current Report And The Date Of The Last Prior Written Report.

STUDENT CODE OF CONDUCT

TEC § 37.001

- (7) Prohibit Bullying, Harassment, And Making Hit Lists And Ensure That District Employees Enforce Those Prohibitions
- (8) Provide, As Appropriate For Students At Each Grade Level Methods, Including Options, For:
 - (A) Managing Students In The Classroom And On School Grounds;
 - (B) Disciplining Students;
 - (C) Preventing And Intervening In Student Discipline Problems, Including Bullying, Harassment, And Making Hit Lists. (1) "Harassment" Means Threatening To Cause Harm Or Bodily Injury To Another Student, Engaging In Sexually Intimidating Conduct, Causing Physical Damage To The Property Of Another Student, Subjecting Another Student To Physical Confinement Or Restraint, Or Maliciously Taking Any Action That Substantially Harms Another Student's Physical Or Emotional Health Or Safety.

"Hit List" Means A List Of People Targeted To Be Harmed, Using:

- (A) A Firearm, As Defined By Section 46.01(3), Penal Code;
- (B) A Knife, As Defined By Section 46.01(7), Penal Code; Or
- (C) Any Other Object To Be Used With Intent To Cause Bodily Harm

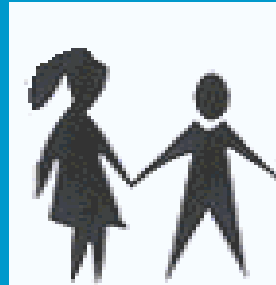
