

INSTITUTE FOR TEACHERS OF THE GIFTED

19 TAC Subsection 89.2. Professional Development:

School districts shall ensure that:

- (1) prior to assignment in the program, teachers who provide instruction and services that are a part of the program for gifted students have a minimum of 30 hours of staff development that includes nature and needs of gifted/ talented students, assessing student needs, and curriculum and instruction for gifted students.
